Conference Proceedings

- All papers presented at the conference will be published in the Conference Proceedings. Authors who want to publish their papers should provide full version of papers. Full version of the papers should be submitted until the (1 September 2016) 40 days after the conference dates. After the review process, revisioned/last version of the paper should be submitted according to date which will given by the MIRDEC boards.
- All the submitted papers in the proceedings have been peer reviewed by the reviewers drawn from the scientific committee, external reviewers, editorial and advisory board depending on the topic, title and the subject matter of the paper.
 - Recommended length of articles is 4-15(tolerated up to 20) pages A4 including abstracts, appendixes and references list.
 - Use single spacing, Times New Roman 11, A4 with 2.5 cm edges.
 - All text in the article is aligned and starts from left side, do not press tab on each paragraph start

Article must be submitted in MS Word format, tables must be editable, charts and other graphics should be in jpeg/gif images or done in **Word/Excel formats. Single spacing, Times New Roman, size 11.**

- The abstract must have minimum of 100 words up to unlimited.. It should be placed only into the field "Abstract" in the submission form. (Please note that It is useful If abstracts can be one-page long (100-150 words).
